Language Instruction for Newcomers to Canada (LINC)

LINC Application Instructions

British Columbia – Lower Mainland

1. Complete the application form on the other side.
2. Photocopy your latest immigration document (one of the following):
 - a) Permanent Resident Card (photocopy both sides of the card)
 - b) Confirmation of Permanent Residence (form IMM5292)
 - c) Record of Landing (form IMM1000 – issued prior to June 2002)
 - d) Notice of Decision from the Refugee Protection Division of the Immigration and Refugee Board (IRB) confirming refugee status
 - e) Letter from Immigration, Refugees and Citizenship Canada (IRCC) giving approval to remain in Canada while your application for permanent residence is being finalized (approval in principle)
 - f) Temporary Resident Visa under CUAET (until March 31, 2025)
3. Mail, fax or bring the completed application form **and** a photocopy of your immigration documents to one of the following offices:
